Denial

Luke 22:57 But he denied it. "Woman, I don't know him," he said.

Last week we began a look at responses to Jesus during his arrest and trial. Judas began the process by betraying Jesus with a kiss. Now we have another close companion of the Lord stating that he does not know him. This was no surprise to the Lord since he had already told Peter that he would deny him three times before the rooster crowed. Peter had pledged his allegiance to Jesus but he was unable to keep his word. Why would a man who had lived side by side for years with the Son of God deny him? Why would he say that he did not know him?

Peter loved the Lord: he was dedicated to him and he was convinced that he would always remain faithful to him. At the arrest by the Roman soldiers, he was ready to fight to the death. Jesus instructed him to put away his sword and at that moment everything began to fall apart. The plan in his mind fell apart. The Lord was carried off by soldiers. The reason for the arrest was for treason against the Roman government. Peter believed he would be considered an accomplice and would meet the same fate - death. Peter also wanted to stay close to the Lord to see what was happening. Love motivated him to stay close to his Lord. Three reasons then led him to the point of denial - confusion, fear and love. When the Lord looked him in the eye, he left and wept bitterly. He was extremely upset by his actions.

Do we deny the Lord? Do our words show our dedication to him? Do our actions proclaim we are a follower of his? When faced with a difficult situation, will we strongly stand for him? Remember Jesus said to "be faithful to the point of death". He also said, "If we confess him before men, he will confess us before his Father in heaven." Good times or tough times will we confess him or deny him? Let's pray for the strength to do the right things no matter the situation
