# **Right Judgments**

John 7:24 Stop judging by mere appearances, and make a right judgment.

Jesus was declared evil and demon possessed because he healed a man on the Sabbath day. Without putting any thought into what they were saying, they placed a judgment of condemnation of the Lord. He let them know that if they had thought at all about Moses and the law concerning circumcision then they never would have made this accusation. How often do we make judgments without knowing the circumstances? How often do we make judgments based upon how a person looks or the type of clothes they wear? Lawyers instruct their clients to wear very nice clothes when they sit before a jury. Why? Appearance does create judgments within peoples mind. Do we really know the facts before we make a judgment?

I'll share a recent story that I have told a few of you. Last December I took Jack and Dean with me to the Rock Show in Franklin. I always make one trip around the building looking and on the second trip buy a few things I want. On the first trip around a man saw these two boys and said they were the first children to come to his booth and he gave each of them a crystal. They were thrilled and hung on to their treasure. At the conclusion of the first trip I saw a man watching me very closely but I didn't think much about it. About five minutes later a man came up to me and identified himself as an undercover deputy for the show and stated that one of his security guards saw Dean steal the rock that was in his hand. I assured him that was not the case but he did not believe me since he had an eyewitness. We went to the original booth and verified that what I said was true. His evewitness made a wrong judgment. While Dean didn't fully comprehend what was going on, it rather dampened my enthusiasm. Wrong judgments bring hurtful consequences. As Christians, let's be very careful that we have all the facts before we make a judgment. Failing to do so is detrimental.
